J, when talking with them, let them know that for this initial CAPA meeting, we are getting the core group (as set up during a Steering Committee meeting) together to initiate the process for evaluating the Ridgecrest/El Paso 1985 designated route network.

We plan to have the 2002 WEMO route survey maps at this meeting and will use GIS to show the 2002 routes which are not designated in the 1985 system. We can then cooperatively determine what additional routes the team wants to evaluate using the WEMO decision tree. We will also determine who else should be involved in reviewing the routes and the procedure to be followed by the CAPA to complete the process.
